## Ohio City Shootout!

RESIDENT TELLS SECOND DISTRICT POLICING COMMITTEE ABOUT BULLETS FIRED INTO HER HOME

"On July 25th, things changed a lot for me," said Sarah (last name withheld to protect victim privacy during the active investigation). "While in my home, I was reading to my twenty-one-month-old twins and

heard popping sounds coming from outside. I looked out my window and saw people running down the street. I heard two more loud bangs and immediately felt heat and impact."

Multiple gunshot rounds pierced her home, with two bullets entering

the kitchen where her husband Matt was and two bullets entering a bedroom where her children were sleeping. The incident occurred at approximately 8:00 p.m.

She had been shot. Her voice quivered as she spoke. "The bullet pierced my femoral artery, went through my thigh, and struck my daughter's crib."

Leaning on a cane for support, she stood before a group of about thirty neighborhood residents gathered at OneHope NEO on Fulton Road, as part of the 2nd District – District Policing Committee meeting held on the second Tuesday of every month at 6:00 PM, and led by Commander Timothy Maffo-Judd.

Sarah continued. "I was the only one injured. I am so grateful for that, even though I have a bullet hole in my leg."

Matt, a former Navy corpsman, grabbed a belt and immediately applied a tourniquet to her leg. "I am a registered nurse. My husband, thank God, is very trained."

Sarah spent the next week recovering from the gunshot wound at Metro Hospital. "I remember every single minute of it. I never lost consciousness until I went into the operating room. All I wanted to know continued on page 6

## Door-to-door combat: Precinct Captains' ground war on voting

To spread fear among voters, President Trump said in May that he would "do anything necessary to make sure we have honest elections; we have to have honest elections." Given the president's threat, National Guard troops, Immigration and Customs Enforcement (ICE) officers, or unauthorized private militia, could appear at polling locations during the midterm elections.

Deploying armed federal agents or military forces is illegal under long-standing federal law, but, according to Deb Kline, "it may not matter."

Kline is one of hundreds of precinct captains that form the grassroots backbone of the Cuyahoga County Democratic Party (CCDP). She serves as the Democratic Club president for Cleveland's Ward 12 and as a fourth-term president of the Office and Professional Employees International Union (OPEIU) Local 1794.

As a precinct captain, Kline attends CCDP and local block club

meetings, canvasses her precinct, registers voters door-to-door, and serves as a liaison between the Democratic Party and community residents. She also recruits, organizes, trains, and manages team members and volunteers.

"Door-to-door knocking is successful in reaching voters, but people are not opening their doors, so we leave packets for them," she said, adding, "The voting rules have changed in Cuyahoga County, making it difficult for people who have not voted during the past two years. They are effectively purged from party affiliation and registration."

In 2018, the U.S. Supreme Court upheld Ohio's controversial "use-it-or-lose-it" voting law, which allows the state to strike voters from the registration rolls if they do not return a mailed address confirmation form and don't vote for another four years, or two federal election cycles. Ohio is the only state with a process based on failure to vote

## Food bank set to open west side center next January

The Greater Cleveland Food Bank is set to open its first West Side Community Resource Center (CRC) in January 2027 on the corner of W. 98th St. and Lorain Ave.

At a community meeting at the site of the upcoming center on August 12,

Greater Cleveland Food Bank President and Chief Executive Officer (CEO) Kristin Warzocha explained that, like its east-side counterpart, which opened in November 2023 on S. Waterloo Rd. in the North Collinwood neighborhood, the new center will be a place for people to access free food in a grocery-store-

style environment. While they're there, they will also be able to access free resources from the food bank's partner organizations, including Cuyahoga Community College, Neighborhood Family Practice, Goodwill, and Digital C. Representatives from Cuyahoga Job

# Community challenged to increase diversity of the participants at Policing Committees

When the Federal Consent Decree Monitoring Team met with Cleveland City Council's Safety Committee in May of this year it was evident from their testimony that the City of Cleveland has a ways to go to become in substantial and effective compliance with the Consent Decree agreed to by the City and the United States Department of Justice in 2015. In the Consent Decree, the City of Cleveland agreed to make a number of reforms in the way the City of Cleveland Division of Police interacts with the public.

## NEWS ANALYSIS

An article in the June 2026 *Plain Press* by Chuck Hoven titled "Federal Consent Decree Monitoring Team reports to Safety Committee" describes some of the areas that the Monitoring Team felt needed more work. One of those areas of concern was meeting the goals of a section of the Consent Decree titled "Community Engagement and Building Trust."

Monitoring Team Member Charles See, testifying about the Monitoring Team's Report, said the report noted the role of the District Policing Committees (DPC) in keeping the public appraised of crime reduction efforts and safety improvements as well as in gathering information and feedback from the community.

However, See said the Report expressed concern about the lack of diversity (race, age, gender and background) of those attending DPC meetings.

At the City Council Safety Committee Meeting, the Monitoring Team promised to join with the City of Cleveland administration in holding working group meetings with the District Policing Committees, the Cleveland Division of Police, and the Cleveland Community Relations Board to explore ways to "expand community participation."

As is evident in the lead article in this issue of the *Plain Press* by Bruce Checefsky titled "Ohio City Shootout: Resident tells Second District Policing Committee about bullets fired into her home," the District Policing Committees are engaged in gathering feedback from the community.

However, the challenge of getting a diverse group of residents to attend the meetings remains. Reflecting on the origins of the District Policing Committees gives some insight to the intent of the committees designed by. Community Relations Board staff member Chuck Habjan in the early 1980s.

When first created, the committees were called Police Community Relations Committees. An article by Chuck Hoven in the January 25, 1982 edition of the *Plain Press* titled "Better communication is the goal: City sets up program for police and residents" includes some comments by Chuck Habjan about the hopes for the committees. In the article, Habjan said, "Barriers which exist between citizens and police officers are based upon a lack of communication. This leads to a lack of understanding by both citizens and the police officers of their roles and responsibilities."

At the time, Habjan said he felt the committees will increase the opportunity for mutual cooperation between residents and police in solving problems. Although unsure of what will result from the program, Habjan believed that "whatever happens will be positive."

In the same January 25, 1982 issue of the *Plain Press*, another article by Chuck Hoven titled "With proper care, Community Relations Committees can work" examines how committee members would be

chosen in the Second District. At that time, the Second Police District had ten police patrol zones. Meetings were held in each of the ten police patrol zones where residents of those police patrol zones elected a representative to serve on the Second District Community Relations Committee.

The article urged residents to attend the meetings in the police patrol zone where they lived and vote. It said, "It is important that community residents come to the initial meetings (see box listing meeting dates, times, and locations) to assure that their interests are represented and that people knowledgeable about the area and its problems will be selected to serve on the committee."

The use of patrol car zones in the Second District resulted in an ideal opportunity for dialogue between resident representatives and police officers that patrolled the zone that they represented. The article said, "One hopes that such efforts will result in mutual problem-solving effort with police and citizens working together toward safer city neighborhoods."

## Community Policing Committees today

Recently, *Plain Press* Editor Debbie Sadlon and I attended the Southeast Asian Festival at Edgewater Park to take some photos for the *Plain Press*. The City of Cleveland Community Relations Board had a booth at the festival. We had a chance to chat with long time Community Relations staff member Tammy Hanna. She served for many years as a staff member for the First District Community Relations Committee (now First District Policing Committee) and is now in charge of helping residents organize a Neighborhood Watch.

Hanna said that none of the Cleveland Police Districts operate with patrol car zones anymore. She said even in the 1980s when the District Community Relations Committees were formed, only the Second and Fourth Districts operated that way. Now individual zone cars respond to calls throughout the Police District rather than in a particular zone.

However, she said Policing Committees still have elections for Citizen Co-Chair and Secretary. Some District Policing Committees also elect a Treasurer.

## Increasing Community Participation

Any resident can attend a District Policing Committee meeting. The meetings are open to the public. It is not necessary to be elected to a position to speak and share ideas at the meetings.

One way to increase resident presence and represent neighborhood interests would be for more neighborhood residents to take advantage of the service offered by the Community Relations Board's Neighborhood Watch program run by Community Relations Liaison Tammy Hanna.

Neighborhood Watch is designed to help residents set up a block club. Once the Neighborhood Watch block club is set up, residents can discuss whatever issues are important to them. If a crime issue comes up, they can make sure members of their group attend the District Community Policing Committee meeting to bring the issue to the attention of the District Commander and the Policing Committee.

## Proposed Medicaid work-requirement rules explained

*The following article was drafted by Northern Ohioans for Budget Legislation Equality based on analysis that was published by Families U.S.A. and is designed for everyday residents, families, caregivers, seniors, and community leaders. The article explains—in clear, accessible language—how the new proposed Medicaid work-requirement rules would operate alongside H.R. 1.*

### Federal Medicaid policy changes

A sweeping set of federal policy changes are underway that could reshape Medicaid access for thousands of Ohioans. The Centers for Medicare & Medicaid Services (CMS) has released proposed Medicaid work-requirement rules, designed to operate alongside the mandates already established under H.R. 1. Advocacy groups—including Families U.S.A., whose analysis informs this report—warn that the combined framework may create significant barriers for vulnerable residents unless the public speaks up during the federal comment period.

Members of the public received a narrow window to submit comments to the Federal Register, the deadline was July 31st.

The new proposed rules in-

clude: new applicants must show compliance for 1–3 consecutive months before applying; current enrollees must show compliance for 1–3 months, not necessarily consecutive; states decide the duration and whether months must be consecutive; medical frailty must be documented; medical frailty must be reverified annually; and no long-term medical frailty status exists.

### Work Requirements Under H.R. 1

House Resolution 1 (HR1) establishes strict criteria for demonstrating compliance with federal work-activity rules. To maintain Medicaid eligibility, individuals must meet one or more of the following monthly requirements: work 80 hours; complete 80 hours of community service; participate in a work program for 80 hours; be enrolled at least part-time in an education program; earn monthly income equal to minimum wage × 80 hours (currently \$580 per month at \$7.25/hour); and job-search activities and job-search training programs DO NOT count toward work requirements.

include institutions of higher education and career/technical programs which include high school programs, and state-approved programs leading to high-school equivalency.

Community Service work done to fulfill work requirements must be unpaid, performed for the direct benefit of the community, conducted under a public or nonprofit organization, and include documented tracking of dates and hours and must be non-partisan.

Exempt individuals include: individuals under age 19; people entitled to Medicare Part A or B; Adults over 65, blind, or disabled with limited income; Supplemental Security Income (SSI) recipients; pregnant women (during pregnancy and 60 days postpartum); children

receiving Title IV-E adoption, foster, or guardianship assistance; and individuals incarcerated at any point in the prior three months

These individuals are *excluded* from work requirements entirely: foster youth under age 26 who were Medicaid-enrolled at age 18; individuals eligible for Indian Health Service; caretakers of dependent children under 13 or caretakers of disabled individuals; disabled veterans; individuals who are medically frail or have special medical needs; individuals participants in drug or alcohol treatment programs; and pregnant or postpartum individuals (60 days or up to 12 months if Ohio

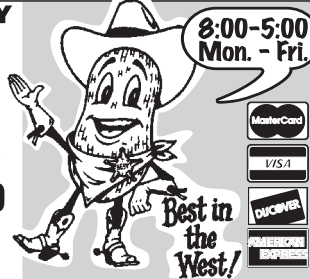

and Family Services will also be on hand to help people apply for SNAP and other government benefits.

“Because in almost every case, hunger is a symptom of another problem,” Warzocha said. “We want to try to address hunger today by making sure that food’s available, but if there’s an underlying issue and we can connect them to a community partner to address that issue, that is a great long-term solution as well.”

Warzocha gave meeting attendees a hard-hat tour of the under-construction building and spoke about some of the features the new center will have,

including a test kitchen where chefs will prepare dishes using ingredients available at the center that day and a large market area where people can browse aisles of food and select what they want. There will also be a play area in the lobby that clients’ children can play in while waiting for assistance.

A large volunteer area – where volunteers can take a break, grab a snack, and store their personal items in lockers – speaks to the outsized role volunteers will play in the daily operations of the center, including greeting and chatting with clients and helping them navigate their way around the market.

“One of the most important things

to us is that everyone who walks in the door is greeted warmly, with a big smile,” Warzocha said. “It can be hard to go into a food pantry or into a soup kitchen or into another agency, and we don’t want people to be embarrassed. We want people to have a great experience when they walk in the door.”

Dwayne Brake, Chief Logistics Officer for the food bank, who also spoke at the meeting, explained that one of the lessons learned from the Waterloo location is the need for renewed focus on security. The new Center will include an unarmed security monitor who will be present in the building, it will have lighting in both of the Center’s parking

lots, 24/7 security cameras throughout the grounds, and private security patrolling the parking lots.

Brake emphasized that all personnel will be unarmed but will be trained in deescalation techniques, Cardiopulmonary Resuscitation (CPR), and first aid.

“We don’t want to have an armed guard’s presence in the building, just because it’s a community resource center,” Brake said. “We feel that a lot of the tension that normally comes in is deescalated through a conversation. Someone’s having a bad day, a lot of negative things are hitting you at once, but you come into the CRC, you see that these services are really helping you, and that really deescalates the situation.”

Brake also said that the building will be equipped with a back-up generator, which will both allow the center to preserve the food in their freezers and coolers and to be able aid neighbors in the event of a power outage or natural disaster.

“I know last year and the year before, we’ve had some extended power outages for several days,” Brake said. “Those are the times when we may have increased traffic coming to the food bank for those emergency services, and we want to make sure that we’re open to be able to provide support in that time of need.”

Warzocha noted that the building was originally built as a Pick-N-Pay grocery store in the 1960s. Since 2006, it’s been home to offices run by Cuyahoga Job and Family Services, but during the pandemic many of the services offered at that center went remote and the space has been under-utilized since.

The Food Bank chose the building after an extensive search and community surveys. Warzocha said they like the fact that the building is close to two bus lines, the number 18 that runs down W. 98th St. and the number 22 which runs down Lorain Ave., and she also expects that many people will come to the center on foot, from

the surrounding neighborhood. She added that their partner the Westtown Community Development Corporation recently received a grant to spruce up the streetscape in the area, including a new mural on the side of the cell phone store across the street from the center, more street trees, and new benches.

More than anything, though, Warzocha said it was the high need in the surrounding area that attracted the food bank to this site. She said that more than 192,000 people who live within a five-mile radius of the building are income-eligible for food from the food bank – that is, they are at 200% of the federal poverty line or below – and of those, about 52,000 are income-eligible but are not being served.

“We’ve got great partners in this neighborhood, for sure, but there is also an extraordinary amount of need,” she said.

While the center’s hours are still being finalized, Warzocha said that, in addition to regular Monday through Friday hours, it will also be open in the evening for at least one day during the week and will be open every other Saturday.

in a single federal election cycle, according to the League of Women Voters and the Brennan Center for Justice.

Kline continued. "There was a time when you could go to a voting poll location, and if you did not have a photo ID, you could use a utility bill to prove where you live. You cannot do that anymore."

Once purged from the list, voters must re-register. "I wish more people would wake up and see what is going on," she said. "There is a lot of fear about the November election, whether federal troops will be at polling stations to intimidate people."

Kline suggests voting by mail, or absentee voting, which could eliminate the need to show up at the polls. Even then, the Trump administration is petitioning the U.S. Supreme Court to allow the nationwide implementation of an executive order that would place major federal restrictions on mail-in and absentee voting ahead of the November midterms.

"As an organizer, I want neighbors to look out for each other because if your neighbor does not have your back when you need them," she said, "then who will?"

Dr. Shereen Naser, a Precinct Committee Member for Ward 11, Precinct E (Precinct 11E), knocks on as many doors as possible to register people to vote and remind them about the midterm elections. The eldest daughter of eight children of Palestinian parents who were displaced from their home, Naser, a Palestinian American, wants to increase the vote for Arab Americans across Northeast Ohio.

"For communities like Palestinian Americans, we are seeing decisions getting made without us," she said, referring to the Israel lobby money in political campaigning. "Over \$30 million was spent on Haley Stevens (D-Michigan), and in Ohio, millions were spent on Shon-

tel Brown in her race against Nina Turner."

Turner lost her race to Brown. Abdul El-Sayed (D) defeated Stevens in the Democratic primary for U.S. Senate in Michigan last August. El-Sayed and Republican former congressional representative Mike Rogers will face off in the midterms. Michigan is a key battleground that could determine the balance of power and control of the majority in Congress.

The American Israel Public Affairs Committee (AIPAC), along with AIPAC shell organizations and the Democratic Majority for Israel (DMFI), is lobbying specifically for a foreign country, said Naser, an associate professor of psychology at Cleveland State University, where she focuses on how marginalized students, especially queer and Arab youth, experience school settings. "We want Israel to stop influencing our political decision-making here in the United States with lobby money."

Her recent research indicates that at least 20% of Americans, including not just Palestinians, witness or experience anti-Palestinian racism, which includes the silencing of conversations about Palestine or being told to remove the traditional keffiyeh, a scarf worn draped loosely around the neck or placed on the head.

"Our civil rights are infringed upon," said Naser. "It's scary. We continue to experience denialism and silencing."

Northeast Ohio has a sizable Palestinian community, between 30,000 and 35,000. Official U.S. Census Bureau figures and American Community Survey reports lower numbers because Arab Americans must use the White checkbox for race identification, which misrepresents them. Middle Eastern or North African (MENA), a new checkbox, will appear on the census and federal data collection forms in 2030.

"Voter disenfranchisement in

the Palestinian and Arab communities stems from a feeling of being erased. Our elected officials do not represent us. Almost every City Council member has gone on paid trips to Israel, along with major people from our top nonprofit organizations," Naser said. "We feel unseen."

JaNea Hambrick is a lifelong Democrat and resident of the Buckeye neighborhood. She is president of the Northeast Ohio Young Black Democrats, a regional political group that mentors, recruits, and empowers a new generation of African American leaders across Northeast Ohio. Hambrick is in her second term as precinct captain for Ward 6, Precinct I (Precinct 6I).

With 976 registered voters in her precinct, only 115, or less than 12%, cast their vote during the 2026 primary. "We need to educate people about elections," she said, acknowledging the low voter turnout. "And get them out to vote once they are registered."

A torn meniscus prevents her from walking the neighborhood and knocking on doors, but her voter registration plan includes mailing information to her constituents at least twice before the election. Ward 6 faces many challenges, she said, including finding things for kids to do in their spare time, abandoned and boarded-up buildings scattered throughout the neighborhood, and significantly elevated crime rates. The overall crime rate in Cleveland is 154% above the national average.

Hambrick worries that Democratic candidate Amy Acton may have dampened her chances to win the seat for governor of Ohio after anti-transgender comments she made regarding the U.S. Supreme Court's recent decision to uphold state bans on transgender athletes. In June, Acton told the Toledo Blade that she did not support boys playing in girls' sports and would enforce and uphold the law as governor. Her comments sparked

controversy within the LGBTQ+ community, and at a meeting a few weeks later to address the issue, she did not show up.

"I will do whatever I can to get Acton into the governor's mansion," Hambrick promised. "I don't think she is transphobic or homophobic. She got poor advice, and it was a mistake for her not to be there."

Acton is running against Republican frontrunner Vivek Ramaswamy in the general election on Novem-

ber 3, 2026. Recent polling shows both candidates drawing 47% of the vote in a head-to-head match-up.

was whether my kids were safe.”

Unable to get around the house following surgery, she relies on a cane and walker for support, and hopes her recovery goes well. A lifting restriction prevents her from picking up her children. “They don’t understand that Mommy can’t pick you up,” she said. “Knowing my neighbors did this is the most mind-blowing part of it all.”

With her sense of safety shattered because of the shooting, living and raising her children in Ohio City may no longer be an option for Sarah’s family. She is actively looking for a home in other cities. “I’m scared, so I’m looking at other cities,” Sarah said. “I want my kids to play outside and read to them in their room in the safety of my house without feeling like something could happen, like a bullet flying through your wall.”

Visibly upset while she spoke, knowing the suspects responsible for the shooting were released from jail, she continued, “I fear extra for my family and myself. It was such a tragic and traumatic event.”

Shannon M. Musson, who serves as Supervisor within the General Felony Division at the Cuyahoga County Prosecutor’s Office and regularly presents updates at the meeting, was not there to explain why they were released. Her father passed away unexpectedly the day before.

When done speaking, Sarah thanked everyone. Applause filled the room. Maffo-Judd, born and raised in the neighborhood, said, “You have come to the right place.”

A couple of days before the community meeting, Ward 7 Councilman Austin Davis issued a press release with information that Cleveland police officers arrested 75-year-old Venancio Camargo Sr, 46-year-old

## Hiking across the Southern Buckeye trail

I crossed into Ohio at Belpre on the American Discovery Trail (ADT), finally leaving behind West Virginia. The people of West Virginia were friendly to me from the moment I entered the state officially at Green Spring until the very end at Parkersburg. Many of the towns along the trail in West Virginia are hollowed out, littered with empty buildings and aging relics of an industrial past. But the people maintain a resilient spirit, proud of their past and happy to share what they had. Even the rudest of West Virginians were generous, with one woman complaining to me about “You city people,” while re-filling my water bottle. She laughed when I griped about the whippoorwills waiting until 9PM to start their racket.

Crossing the bridge over the Ohio River from Parkersburg into Belpre filled me with a bittersweet feeling. I had many happy and interesting episodes in West Virginia and saw corners of it I never would have seen otherwise had it not been for the American Discovery Trail. But I was glad to be back in Ohio, and even though I technically wasn’t close to home, I still felt the warmth of familiarity. I was near vistas I had seen before and highways I recognized. My goal was just to make it to Cincinnati where I would take a bus or call for a ride back to Cleveland.

From Belpre, I hiked through heat hoping to make it to Chesterhill, where the ADT officially meets the blue-

blazed Buckeye Trail (BT) which it follows to Cincinnati. But when I came to a covered bridge that physically allowed only for foot traffic, I collapsed and slept for the night in it. I never felt more like an Ohioan.

I made it to Chesterhill the next day and followed the blue blazes to Burr Oak State Park. In the park, I talked with a ranger and asked her about the water sources. I noticed how a lot of the water I saw flowing looked chalky. “Even if you filter it, I don’t think any of the water in southern Ohio is potable,” she warned.

Rain slowed me down at Burr Oak, and I stayed the night there when it rained even more. In the morning, I ate the breakfast buffet at the park lodge and continued on the trail, where I met my first wildlife obstacle: the castleback orbweaver. Hundreds of these spiders had spun their webs across the trail. At first, I felt guilty for demolishing such beautiful homes; but after miles of relentless annoyance, I could not feel anything for a spider stupid enough to build a web where a human being would stomp through it. I’m sure the gnats and flies were grateful for my presence. I was grateful to find a stick I could carry to wave in front of me as a buffer until my arm tired.

After a taxing hike through Wayne National Forest that was heavy on the forest bathing, I made it to Murray City, which is a small town. I hiked through it and went down the road looking for my next trailhead. I passed a sign on a gate to my right that read, “Do not blow gate.”

“That’s a weird phrase,” I thought. There was a boom mower truck inching along, so I hurried past it, making sure to keep my eyes on the road and the mower truck. But my trail turn-off was near, I knew.

In time, after a couple hills, I did see to the left where the trail turned. So, I entered and trucked on through the woods. Something felt off, but I was following the blue blazes, so I had to be going the right way. Right before the next road crossing, someone was nice enough to leave a cooler with water bottles for hikers, which was a very welcome sight given how parched the area was. But I still felt uneasy about something.

Venancio Camargo Jr, and 21-year-old Daniel King-Camargo, a family trio of grandfather, father, and son, on attempted murder and felonious assault. They were later charged with additional crimes.

According to Davis, and verified by police reports, a gunfight broke out over a car detailing job following a verbal confrontation between Camargo Jr. and the 24-year-old auto detailer victim, whose name has been withheld during the investigation. Multiple rounds were fired. Two unintended bystanders were injured, including Sarah, and a 42-year-old man standing on a neighboring porch, whose identity was not publicly released by the Cleveland Division of Police pending an ongoing investigation.

Cleveland Police, assisted by SWAT, executed search warrants at nearby residences, recovering a .45-caliber handgun. Court indictments and search warrants also list an assault rifle, alongside multiple recovered firearms and ammunition from nearby residences, and a second handgun.

Camargo Sr. was indicted by a grand jury and released after posting a \$100,000 bond.

Camargo Jr. and King-Camargo appeared in Cuyahoga County Common Pleas Court, pleaded not guilty, and were released after posting a \$250,000 bond. The defendants are charged with attempted murder, felonious assault, discharging a firearm near prohibited premises, improper discharge into a habitation, tampering with evidence, and vandalism. Judge Jeffrey Saffold is presiding over the case.

Brian McEntee, Second District Captain, praised Sarah and Matt for their bravery. He provided context for the investigation, saying that within 72 hours, warrants were issued, indictments were handed down, and evidence was collected from the crime scene.

“You guys are truly victims in this thing,” said McEntee. “But you are also heroes because you saved yourselves. I have seen people shot in their femoral artery. They do not make it. You saved yourselves,” and stated that the incident was not a sign of gang violence in the neighborhood. “This activity did not involve drugs, and the shooting was irresponsible. People were not thinking.”

Police responded immediately, he added. “We will continue to follow the investigation. I know these types of situations can create panic, fear, anxiety, and concern that it might be part of a chronic situation. I am here to say that in this area of the city, it is not.”

Davis said earlier in the meeting that he would use the power of City Hall to curb the violence and offered support from City Hall. “Obviously, this matter is horrible with the number of shots fired and people injured, and the connection to the neighborhood block,” he said.

Maffo-Judd was wrapping up the hour-long meeting. “It took a lot of guts to come out and do this tonight,” he said to Sarah and Matt. “I said it once, and I’ll say it again. You guys

are the best community in the city, and it shows.”

Cleveland’s gun death rate is three times greater than the national average, according to the city’s annual Violence & Injury Report, with a significant surge of gun violence on the Near West Side in recent months. Maffo-Judd reported that Second District police responded to 3750 calls for 911 service in July alone, with 97 arrests, and 567 arrests since the beginning of the year. For any active crime emergencies or life-threatening situations on Cleveland’s West Side, dial 9-1-1 immediately. For non-emergency crime reporting or suspicious activity, call the Cleveland Division of Police Non-Emergency Number (216) 621-1234.

I exited this little patch of trail back onto the road. My compass kept saying I was going SE, which was the wrong direction; but still I followed the blazes until I came across a gate to my left with a weird sign on it. “Do not blow gate,” it read.

I was emptied. “Either I somehow entered a mirror universe from *The Twilight Zone*, or I got turned around.” Sure enough, I kept going and re-entered Murray City.

“I’m done,” I said to myself but with much coarser language. Where I passed the boom mower must have been where I was supposed to enter the trail, but I wasn’t paying attention and didn’t see it. And I just didn’t have energy to turn around to try again. So, I went up to a house that appeared friendly, hoping for a ride into Glouster where I could catch a bus back to Cleveland. A woman was outside of it and seemed a bit startled to see me. After not having bathed in over a week, I didn’t blame her. She was hesitant to talk to me and seemed wary. But she picked up on how desperate I was and fed me a large dinner of pulled pork and chips and soda and anything else she could readily make. And she even offered to drive me into Glouster, “As long as you don’t stab me!” she said. “I’ve heard of stories like this on the ID channel!”

With both of us fully alive and me with a full stomach, she drove me into Glouster and dropped me off at the library with some advice on how to get back to Cleveland. But I was feeling demoralized. I would be quitting right before going through Hocking Hills, which I had always wanted to visit. But now, sitting inside an air-conditioned library with my caloric tank re-filled, I felt reinvigorated enough to try again. I connected with Ann Furst, who is the chapter head of the Buckeye Trail in that area. She was kind enough to pick me up in the morning and send me off with the encouragement that I could finish.

I trudged along the trail, meeting more friendly people along the way who were willing to give me bottles of water or let me use their spigot. I mentioned to them that water should not be chalky or taste off. No one seemed completely confident in their own water, and virtu-

natural features of the Hocking Hills were carved by erosion over millions of years. Despite being packed with tourists snapping photos, these features were still worth seeing. It seems almost sacrilegious to use something so ancient and enduring as just a pretty backdrop for an Instagram picture.

The Buckeye Trail passes through many state parks, each with their own distinct characters. Going west, after Hocking Hills State Park is Tar Hollow State Forest, a wilderness preserve which must be like what the pioneers encountered. True to its name, it really is hollow and devoid of almost anything except dense forest. The Scioto Trail State Forest after this is a little less barren & unforgiving, having been trekked by the natives thousands of years ago. After this is Pike Lake State Park, which

logs and branches ahead of me to keep the vines down. It wasn’t enough. My arms and legs were cut up and bleeding like a scene from a *Saw* movie. Despite that, I still had physical energy to keep going. But my patience had run dry. So, when I saw a church camp at a road crossing, I went down there to plead my case. They let me stay the night, and my mom picked me up in the morning.

It was an interesting adventure, but based on the sections I did, I cannot recommend the Buckeye Trail to thru hikers in its current form. Far too much of the trail is unmaintained, being covered by thorn bushes and tall grasses. My body became a warehouse for all kinds of bloodsucking creatures. This is expected when hiking, but regular trail maintenance can minimize this. Avoiding tall grasses is especially important

ally everyone drank out of water bottles. One person told me how lime is added to mine runoff water to neutralize acidity which makes the water look chalky, but it is drinkable. Cloudy, “technically drinkable” water must be the price we pay for progress.

Eventually, I did make it to Hocking Hills State Park. It looked like a scene out of Middle Earth or the American southwest, including being layered with sand over 350 million years old. The

was a bit overgrown but had a nice camp store and nature center.

But before I could make it to the Serpent Mound Memorial Site and still well before my destination of Cincinnati, my journey reached a frustrating stop. The overgrowth of the multiflora rose bush was just too much for me to tolerate. This invasive rosebush is nature’s living, growing barbed wire. Large sections of the trail were impassable, but I was foolish enough to try by throwing

given the rise in tick-borne diseases.

Furthermore, the grading of the trail feels suspect, with seemingly plenty of unutilized area for switchbacks. Fallen trees are often left lying across the trail, with blazes painted on them telling hikers that the trail continues behind them. These kinds of conditions encourage hikers to hike off trail, which increases erosion.

Most days, I was the only one on the Buckeye Trail, even on weekends

when trails usually have day hikers. I crossed paths with a woman in Tar Hollow who was doing another trail who told me how she tried a little bit of the BT before. “But never again. It was too overgrown,” she said.

Trails are never finished products. They require continuous monitoring and maintenance and are the responsibility of dedicated workers and users. But trails should also be designed for people and even wildlife to utilize. They are not simply nature’s treadmills, and they should not be maintained simply for the sake of having trails if no one is using them.

However, whether people are thru-hikers or not, the environment is everyone’s obligation. Our actions impact our shared earthly home. It’s not only a good idea to be green- it is vital. Not having potable water was an annoyance for me, but it can be harmful or even lethal to wildlife. Letting invasive species spread wildly can choke out native flora, to which native animals are adapted. Much like the grandeur of Hocking Hills, natural systems take eons to form and carelessly disrupting them can inflict irreparable damage.

Even though mitigating our influence on the environment may be an eternal challenge, with so much knowledge and so much potential for action, it seems wrong not to address it. Because the quality of people’s lives is being

diminished by fixable issues, it’s wrong that neither of the leading gubernatorial candidates prioritize environmental concerns in their campaigns. As I walked past chalky water streams, it felt like the battle had already been lost at every level. If water is the lifeblood of Mother Earth, then we have given her sepsis, with more casualties still to come.

Despite the obstacles and ultimate setback, I don’t regret my time on the Buckeye Trail. I had many wonderful encounters & learning experiences that are too numerous to share. Plus, I lost 15 pounds. The American Discovery Trail peels off the Buckeye Trail in Cincinnati where it continues west all the way to California. It still calls to me. My trail hiking is currently paused but not completely abandoned. Very little that’s worth doing is instantly doable. Large endeavors– whether thru-hikes or environmental problems– are worth tackling at the beginning. And it never makes sense to quit until it’s over.

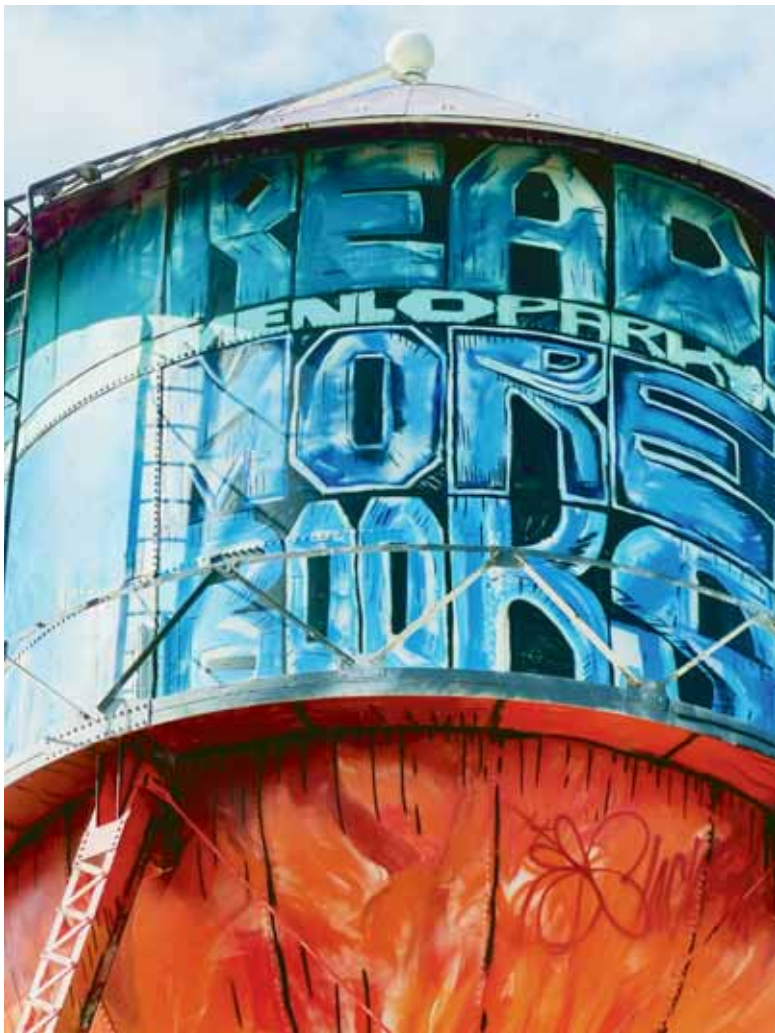

### Polly Karr's Substack reveals political intrigue surrounding local education

For those concerned about the quality of Cleveland schools, reading Polly Karr's Substack is highly recommended.

Karr, a parent with children who are enrolled in Cleveland Metropolitan School District (CMSD), adeptly uses public records and her familiarity with CMSD staff and administrators to shed light on some of the behind-the-scenes antics that are undermining the educational quality in the Cleveland Metropolitan School District.

In her August 22, 2026, blog titled "Poached", Karr begins with a photo sent to her of new hires in the Shaker Heights School District. She recognizes some of them as beloved teachers laid off by CMSD at the end of last school year. She also notes that three finalists for a principal position in the Shaker system were all former CMSD administrators. What is intriguing to Karr is that a Shaker Heights School Board member, Lora Cover, who was involved the hiring of the principal was also a paid consultant to Cleveland Metropolitan School District Chief Executive Officer Warren Morgan in deciding which CMSD administrators to lay off.

Karr goes on to point out that a

new group that is involved in setting up a charter school network called Future Ready has connections to those previously involved with CMSD. Lora Cover is president of the Board of Future Ready. Mayor Justin Bibb's former Chief Education Officer serves as the Chief Executive Officer for Future Ready. Former CMSD Board Member Leah Hudnall is now on the Board of Future Ready.

Karr points out that Future Ready has hired some of CMSD's most innovative principals who were laid off when their schools were merged with other schools last year – Staci Starr of Cleveland Early College and Tim Jones, the founding principal of Davis Aerospace and Maritime High School.

Karr's blog raises concern that the talented staff and innovative programs from Cleveland Metropolitan School District are being poached by suburban school districts and Future Ready. Try googling Polly Karr's blog on Substack for more details.

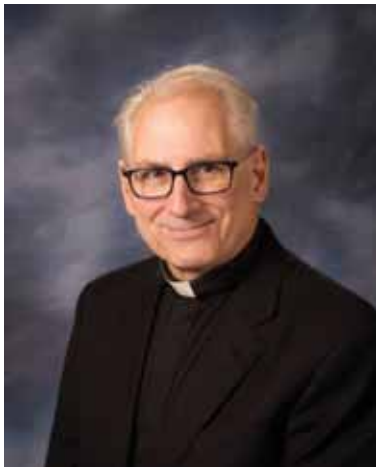

## First Energy profits whether your lights are on or not THE PERVERSE INCENTIVES BUILT INTO OUR GRID

FirstEnergy profits whether your lights are on or not. That is the fundamental problem with the way we regulate electric utilities in Ohio.

For families across Northeast Ohio, power outages are not an abstract policy problem. They mean spoiled groceries, missed work, medical equipment without power, apartments climbing into dangerous temperatures, businesses forced to close, and parents trying to figure out where their kids can sleep safely for the night.

And in too many neighborhoods, this is not a once-in-a-decade storm problem. It has become a recurring part of life.

### NEWS ANALYSIS

Residents in my district have endured repeated outages, including failures during periods of extreme heat. Some neighborhoods have been hit repeatedly. My office has heard from hundreds of frustrated residents asking the same basic question: "How can I pay my electric bill every month and still not be able to count on having electricity?"

The uncomfortable answer is that the system does not provide electric utilities with sufficient financial incentive to make reliability the priority it should be.

#### The perverse incentive built into the system

Investor-owned electric utilities like FirstEnergy do not primarily

make money by keeping your lights on. They make money by investing in infrastructure and earning a regulated return on those investments.

Build a new substation. Replace equipment. Expand transmission. Add new capital to the system. Those investments can be included in the utility's rate base, allowing the company to earn a return for shareholders.

There is, of course, a legitimate reason for that system. The electric grid requires enormous, long-term investments, and utilities need access to capital to build and maintain it.

But the incentives can become badly distorted.

A utility can have a stronger financial incentive to build something new than to simply make sure the infrastructure it already owns works reliably. Spending more money can increase the company's earnings potential, while avoiding outages does not necessarily produce the same direct financial reward.

**Customers bear the consequences when reliability fails, while shareholders can continue earning returns.**

If your refrigerator full of groceries goes bad during an outage, FirstEnergy does not automatically pay for it.

If you have to stay in a hotel because your home is dangerously hot, FirstEnergy does not automatically pick up the tab.

If your business closes for a day,

you eat the loss.

And yet the utility can continue seeking its authorized return.

We should not accept a regulatory system in which customers bear more financial exposure to poor utility performance than the utility's shareholders do.

Reliability should be part of the bargain.

Electric utilities are not ordinary businesses. If you do not like your grocery store, you can shop somewhere else. If you do not like your phone company, you can switch providers. You cannot choose another set of electric distribution lines running down your street.

Utilities receive a monopoly because we have decided it does not make sense to have five different companies stringing competing electric wires through every neighborhood.

But that monopoly comes with an obligation. Reliable service has to be part of the bargain. That means Ohio should begin tying utility earnings directly to whether companies actually meet meaningful reliability standards.

The idea is simple: Full return for reliable power. Reduced return for failure. If a utility meets strong standards, keeps outages under control, improves its worst-performing circuits and demonstrates that its investments are actually making the grid more reliable, it should be able to earn its full authorized return.

# Cuyahoga County Board of Elections’ website offers information on registering and voting

Citizens, age 18 or older by election day (November 3, 2026), are eligible to vote in the General Election once they are registered to vote. The deadline to register to vote in the General Election is October 5, 2026.

To register to vote, to check to see if you are registered to vote, or to update your voter registration information, you can visit the Cuyahoga County Board of Elections website at [boe.cuyahogacounty.gov](http://boe.cuyahogacounty.gov). Once there, click on the VOTERS heading at the top of the page. The Board of Elections website provides information on how to register, how to update your registration information, and allows you to check to see if your registration information is correct. Options offered are online, by mail, or in person.

The site offers other options including checking your voting history and checking your ward and precinct.

Voting for the November 3<sup>rd</sup> Gen-

eral Election will begin on October 6<sup>th</sup>. For individuals that wish to vote by mail, the Ohio Secretary of State plans to mail out Vote by Mail applications to all registered voters beginning this September. Registered voters can also vote in person at the Board of Elections beginning on October 6<sup>th</sup>. The Board of Elections is now located at 1803 Superior Avenue. To learn where to park, locations of the drop box, hours, and other information visit [boe.cuyahogacounty.gov](http://boe.cuyahogacounty.gov).

On November 3<sup>rd</sup> General Election ballot, voters will be asked to weigh in on a United States Senate race, and United States Representative race on the Federal level.

Statewide races on the ballot include contests for Ohio Governor and Lieutenant Governor, Ohio Attorney General, Ohio Secretary of State, Ohio Auditor of State, Ohio Treasurer of State and Ohio Supreme Court Justice.

Local State legislative candidates

will also be on the ballot. Voters will choose among candidates running for the State Senate and State House of Representatives.

Cuyahoga County voters will weigh in on their choice of County Executive and in some County Council Districts candidates will also be on the ballot.

There will also be judicial races on the ballot for candidates running for the 8<sup>th</sup> District Court of Appeals and candidates for the Court of Common Pleas.

There may also be a Cuyahoga County tax levy on the ballot.

When the ballot information has been prepared by the Cuyahoga County Board of Elections, you can view a sample ballot for your precinct on the Board of Elections website at [boecuyahogacounty.gov](http://boecuyahogacounty.gov).

The Board of Elections is also seeking poll workers to help on election day. Pay starts at \$220 a day. To sign up, visit the Cuyahoga County Board of Elections’ website.

If the utility repeatedly fails those standards, shareholders should feel the consequences -- not just the utility's customers.

We do not have to invent this from scratch.

Ohio would not be the first state to rethink how utilities are rewarded.

New York has perhaps the clearest example. Its Public Service Commission sets reliability targets for electric utilities based on measures such as how frequently customers lose power and how long outages last. When utilities miss those targets, regulators can impose negative revenue adjustments. Poor reliability can directly reduce utility earnings. That is exactly the kind of financial accountability Ohio needs.

New York has also gone further in recognizing something obvious that our current system tends to ignore -- prolonged outages cost customers real money.

Under New York’s rules, customers affected by qualifying extended outages can receive reimbursement for spoiled food and refrigerated prescription medications. Residential customers can also receive bill credits when outages stretch

beyond certain periods.

That changes the incentive.

When the power goes out in Ohio today, the household throwing away \$200 worth of groceries absorbs the loss.

Under a stronger accountability system, the utility begins absorbing some of the cost of failure too.

Hawaii has gone even further toward a broad performance-based regulatory model. Utilities there can receive financial rewards or penalties tied to measurable performance, rather than relying almost exclusively on the traditional model of earning money through capital investment.

Massachusetts also uses service-quality and reliability standards that can expose utilities to financial penalties when they fail to meet established benchmarks.

These states have different systems, and Ohio should design its own. But the principle is the same:

Utility profits should depend, at least in part, on whether customers are actually receiving good service.

### What Ohio Must Do

We should build a system around a few straightforward principles.

Tie utility returns to reliability. Utilities that meet strong reliability standards should be eligible for their full return. Those that repeatedly fail should receive less.

Put the worst-performing circuits first. Utilities should identify the neighborhoods and circuits suffering the most frequent outages and be required to demonstrate measurable improvement.

Compensate customers for prolonged outages. Families should not be left holding the full cost of spoiled food, medications, and other predictable losses caused by extended outages.

Make shareholders bear the cost of failure. Penalties and customer compensation should not simply be rolled into the next rate increase and handed back to customers.

Reward outcomes, not spending. The goal should not be to see how many billions of dollars a utility can put into its capital plan. The question should be whether those investments actually produce a more reliable electric system.

This is the kind of reform I want Ohio to pursue.

We have already begun strengthening reliability standards in state law. The next step is giving those standards teeth.

A reliability requirement without meaningful financial consequences can too easily become another report filed with a regulator.

If we want utility executives and investors to treat reliability as a top priority, then reliability needs to

determination

If an applicant or recipient is found to be non-compliant then the states must allow individuals to receive 30 days to make a “satisfactory showing”; send denial/disenrollment notices that include specific reasons; and states may not restrict reapplication or future eligibility.

The proposed rules—combined with H.R. 1—could create significant administrative burdens, increase disenrollment, and disproportionately affect low income workers, caregivers, and individuals with unstable health conditions.

affect the bottom line.

### The Lights Come First

A monopoly utility should be able to make a reasonable return when it provides good service. We need financially healthy electric utilities that can invest in our grid. But a reasonable return should NOT mean an automatic return regardless of performance.

Ohioans are paying higher electric bills while being asked to tolerate repeated outages. At the same time, the electric system is facing enormous new pressures from extreme weather, aging infrastructure and unprecedented growth in electricity demand.

The answer cannot simply be to keep asking customers for more money.

We need to ask what customers are getting in return.

For too long, our system has treated utility profitability as a given and reliable service as an aspiration.

We need to reverse that. If customers are expected to pay their electric bill every month, utilities should be expected to keep the lights on. And when they repeatedly fail, utility company shareholders should not be guaranteed business as usual.

# Plan for corner of Memphis and Pearl continues to evolve

I don't know what image makes me feel sadder — the one in last month's issue of the backhoe in front of Pearl Road United Methodist Church, scooping up the remains of what was once the Greenline Building; or the one in this month's issue of the gaping split between the two beautiful buildings which were once St. Luke's United Church of Christ; or the one in my mind of the empty window frame toward the top of St. Luke's 1925 addition which a three-part stained glass window once filled.

Fortunately, I have some positive thoughts in my mind, too — I'd written to Mary Ann Winkowski (Cleveland's "Ghost Whisperer" of international fame) about the demolitions at Memphis and Pearl and I received a response from her; The Historical Society of Old Brooklyn (HSOB) has had its holdings moved out of storage and into its new quarters on Broadview Rd.; and David Robinson, the relatively new executive director of the Old Brooklyn Community Development Corporation (OBCDC), reached out to me and has been answering in great detail the questions I have tried to get answered for what seems like a very long time.

First about Mary Ann Winkowski — I am not the only person in Old Brooklyn who has been concerned about the earthbound spirits who have been disturbed by the recent digging and demolitions at Memphis and Pearl. Such spirits are generally known to frequent cemeteries, and they are specifically known to have lived in the c.1860 house behind St. Luke's which has now been demolished. I further suspected that souls of past members of St. Luke's were not happy to see their church and the addition to it being hacked apart. So, knowing that Mary Ann is semi-retired and not knowing what I would need to pay her if she even would agree to come to our site, I decided to write to her. I received a prompt, cordial reply stating that she is indeed semi-retired and due to age and health issues with both herself and her husband she had

when the Krather Building was being restored (not demolished; restored) and something happened with the parapet wall along the edge of the roof, and a worker fell to his death.

Moving on to the Historical Society of Old Brooklyn (HSOB), the interior painting and modifications of their new space have been completed, the HSOB arranged for the contents of their previous museum in the Greenline Building to be moved from storage to their new storefront on Tuesday, August 4th. They've been able to lease the space at 2221 Broadview Rd. (just north of Colburn Ave.) for two years, thanks to the financial backing of the Old Brooklyn Community Development Corporation (OBCDC).

The HSOB was open for visitors for the ArtHop three days after the move, but most of their items were — and still are — in boxes. Unpacking and reorganizing in a new space is a gargantuan task for anyone, and especially for the mostly older members of the organization. John Rakauskas and Lorelei Greifenstein, both of whom are trained in design, are currently working on developing signage for the windows.

For decades the HSOB has opened its annual every-other-month meeting season on the second Friday of September but as of press time, nothing definite has been arranged. Check their Facebook page or website, [oldbrooklyn-history.org](http://oldbrooklyn-history.org), for updated information.

In last month's article, I paused this "story without an ending" at the point four years ago when OBCDC didn't receive the Low-Income Housing Tax Credits for which they'd applied to help fund this project. And I said that I would pick up with the chronology of the project there this month. What I didn't know then that I would be communicating with David Robinson in the meantime and that he would express a willingness to answer my questions that City Hall has been repeatedly ignoring.

I still intend to pick up with my view of the continuing saga of the corner in a future issue, but so much has changed — and is continuing to change — with the project since its

inception that it seems to be more important this month to start sharing the information I received from David Robinson. There is so much, I hardly know where to start...

Whether OBCDC had the necessary funding for this project has been one of my biggest concerns, and repeatedly we were told both that it does, or that it will. When the demolition started, I wanted to believe that total funding had been secured because we were promised by more than one party that demolition would not begin until the "capital stack" was in place.

In a previous issue I even reprinted all the funding and expected funding sources from an online publication named NEOtrans whose editor, Ken Prendergast, has been following this project. But as it turns out, the only funding that was a sure thing was the approximately \$8 million in grants for the demolition and brownfield remediation which has been going on recently. At least one of those grants expire at the end of this year and that seems to be the reason why the City permitted the current demolition. The rest of the plans for the corner and how to finance them have not been determined.

The fact that the plan for the corner of Memphis Ave. and Pearl Rd. continues to evolve is not a bad thing. I don't know anyone who wanted a six-story modern monstrosity on the second most important, majorly historic intersection in our neighborhood. (Especially the people who would live next door, or in close proximity to it.) And such a building would dwarf what will remain of the landmark St. Luke's after the northern half of it is removed

But exactly what will be built on that corner is presently unknown. OBCDC no longer has unit requirements from HUD (the U.S. Department of Housing and Urban Development) since it decided against using financing through HUD or backed by HUD. That sounds like their previously arranged loan through the AFL-CIO (American Federation of Labor-Congress of Industrial Organizations) is out of the picture, too.

So, the threat of 84 apartment units is no longer a reality. Nor is tearing down a major portion of Pearl Road United Methodist Church, including the former YMCA gymnasium on the uppermost floor, to provide space for some of those apartments. We won't have to wonder where all the people who might want to live in the new apartments will park their cars because it's looking like such a huge apartment building won't be going up there.

Another major change in the scheme of things is in regard to who will own the new construction after it's finished. In the proposal which Tom Yablonsky's group submitted, the developer would have owned the

building and have taken on all the financial liability for the project after the Federal and State historic preservation grants were used up. But OBCDC thought that they wanted to own the new apartment building (at least partially) so that they would have more control of things and presumably an income source after the construction loans were paid off. A look at Cuyahoga County's MyPlaces website reveals all the parcels OBCDC owns on or near that corner, including Pearl Road United Methodist Church, which the congregation deeded to OBCDC on January 28th of this year.

But OBCDC has been viewing things differently lately. Maybe it started in 2025 when they weren't awarded the \$15 million in TIF grant money they needed to complete their capital stack. Maybe it was the change in executive directors that same year. Maybe somebody realized that they had bit off more than they could chew. But the bottom line is that now OBCDC no longer wants to retain ownership of all these properties. Currently they still do own them, because the dollars in the grants were given to them. But the demolition and remediation will soon be completed and OBCDC will transfer the ownership of the properties to the developers and possibly other investors. A process is underway to engage commercial entities with the redevelopment of the corner, and it has sparked some interest. Still, it doesn't sound like new construction will be starting any time soon.

Meanwhile, the stained-glass windows from St. Luke's have all been removed and are being stored safely onsite for potential use in the new construction or replacement in the windows of the 1903 church. Even as I prepare this article for publication, the roofing material is being scraped off the church section of St. Luke's. The storage tank which was buried between St. Luke's and the Greenline Building was removed and examined and found to be empty. Reportedly no human remains were found in the old cemetery when the backhoe machinery dug up the ground. (Probably it would take someone with an eye fine-tuned to changes in soil composition to find human remains after almost 200 years.)

Next month I might choose to be more specific about the legislation involved in the happenings at our iconic corner; this month I was more interested in simply getting out the word. 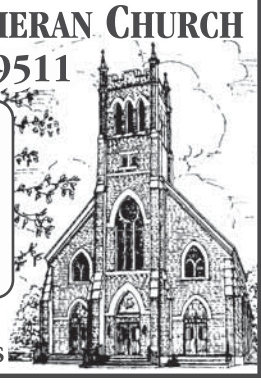

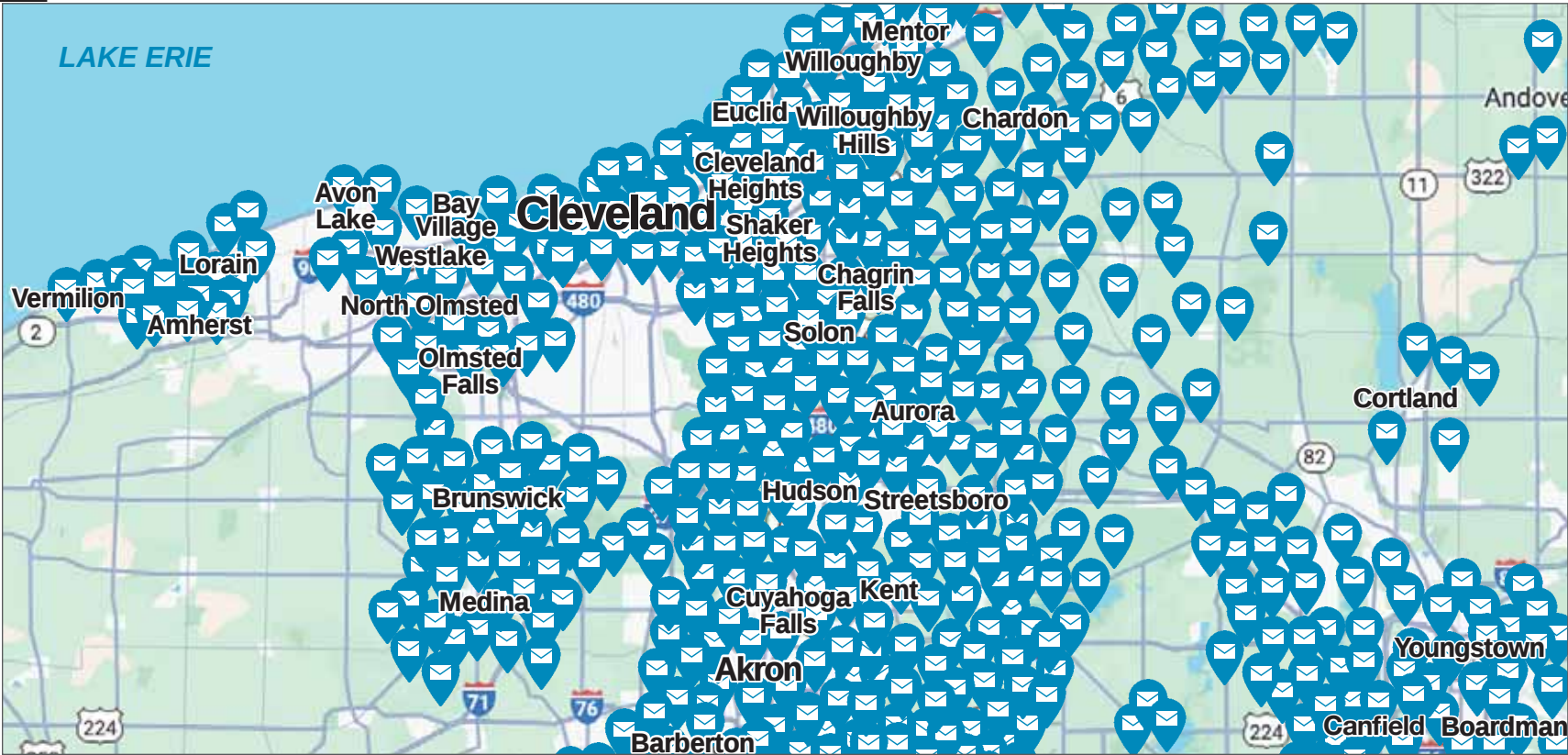
